Note : * Owing to bilateral arrangements, there would be different Business and Employment visa fees for specified countries at the rates indicate in Para 12.

*Please note that :

- For Urgent Visas (Zimbabweans), there will be an additional charge of USD 20.00 per visa.
- Visa is gratis for the nationals of **Afghanistan, Argentina (only Business, Tourist and Transit visa/Normal visa fee is applicable for all other types of visas), Bangladesh, DPR of Korea, Jamaica, Maldives, Mauritius, Mongolia, South Africa and Uruguay (only Tourist/ Normal visa fee is applicable for all other types of visas)**. In respect of **Seychelles nationals**, all type of visa except for **work/employment** may be issued on gratis basis.
- Nationals of Bhutan and Nepal do not need Visa to enter India. However, **Nepali nationals** require visa if they enter **India from China**, which may be granted gratis.
- Pakistani** nationals should be charged Rs. 100 for Indian visa of all types.
- Special visa fee Categories:
 - Singaporean nationals** : The charge of tourist visa is US\$25(Single/Multiple upto six months). However, fee for all other types of visas will be the same as applicable for other countries.
 - Japanese nationals** : A fee of US\$ 1.00 for transit visa and US\$ 8.00 for all other types of visas may be charged.
 - Nigerian nationals** : A uniform fee of US\$250 to be charged for all types of visas valid for any duration(as per prevailing instruction).
 - USA nationals** : A fee of US \$ 100 may be charged for Tourist visa only for maximum period up to 10 years including visa application fee. Business visa fee will be US\$ 250.00 for five years. However, fee for all other types of visa will be same as applicable for other countries. Visa application fee of **US\$ 20.00** should be charged in addition to visa fee barring tourist visa.
 - Russian nationals**: For all types of visa fee should be charged US\$ 40.00(Single entry), US\$90.00(Double entry) and US\$ 120 (Multiple entry). Transferring of Valid visa should be charged US\$ 40.00.

8. **Transfer of visa** : A service fee of US\$ 5.00 should be charged when an Indian visa affixed on an old passport is transferred to a new one. **Countries mentioned in para 2, 3 and 4 are exempted.**
9. **Restricted/Protected area permit** : A fee of US \$ 30.00 for issuing restricted/protected area permit should be charged. **Countries mentioned in Para 2, 3 and 4 are exempted.**
10. **Employment Visa and Business visa are Gratis for following Least Development Countries:**
Afganistan, Angola, Bangladesh, Benin, Bhutan, Burkina Faso, Burundi, Cambodia, Central African Republic, Chad, Comoros, Democratic Republic of the Congo, Djibouti, Equatorial Guinea, Eritrea, Ethiopia, Gambia, Guinea, Guinea-Bissau, Haiti, Kiribati, Lao People's Democratic Republic, Lesotho, Liberia, Madagascar, Malawi, Mali, Mauritania, Mozambique, Myanmar, Nepal, Niger, Rwanda, Sao Tome and Principe, Senegal, Sierra Leone, Solomon Islands, Somalia, South Sudan, Sudan, Timor-Leste, Togo, Tuvalu, Uganda, United Republic of Tanzania, Vanuatu, Yemen, Zambia.
