As a minimum, the Bidder is net worth for the last year calculated as the difference between total assets and total liabilities should be positive;
- (b) Minimum average annual turnover for the last 3 years in the amount of \$4 000 000;

(c) Financial situation:

The Bidder must demonstrate that its financial resources, less its financial obligations under

contractual obligations, meet or exceed the general requirements for this contract in the amount of \$660 000;

(d) Successful completion within the last 5 years of two similar contracts where the cost of participation of the Bidder exceeds \$2 500 000;

(e) Experience in the following key activities: SCADA system design, supply and installation.
