**AYUSH Scholarship Scheme 2023-24**

The Embassy of India would like to inform that the Ministry of AYUSH, Government of India has announced ICCR Scholarship slots under AYUSH Scholarship Scheme for the Academic Year 2023-24.

2. Interested Turkmen nationals may apply for UG (Undergraduate), PG (Post-graduate), and Ph.D courses in AYUSH disciplines as follows.

- a) Bachelor of Ayurvedic Medicine & Surgery (BAMS) [ 5½ years]
- b) Bachelor of Siddha Medicine & Surgery (BSMS) [ 5½ years]
- c) Bachelor of Unani Medicine & Surgery (BUMS) [ 5 ½ years]
- d) Bachelor of Homeopathic Medicine & Surgery (BHMS) [ 5 ½ years]
- e) Bachelor of Science (BSc) in Yoga (3 years)
- f) Bachelor of Arts (BA) in Yoga Shastra (3 years)
- g) Postgraduate (PG) in M.D. Ayurveda (3 years)
- h) Postgraduate (PG) in M.D. Siddha (3 years)
- i) Postgraduate (PG) in M.D. Unani (3 years)
- j) Postgraduate (PG) in M.D. Homeopathy (3 years)
- k) Ph.D in Ayurveda (3 years)
- l) Ph.D in Unani (3 years)

3. The application form should be filled online and submitted on the A2A Portal <http://a2ascholarships.iccr.gov.in>. The last date of application submission is 31<sup>st</sup> May 2023.

4. The scholarship provides for Tuition fee, Living Allowance, Contingent Grant, House Rent Allowance, Thesis and Dissertation expenses and Airfare. The candidates are expected to comply with admission formalities and procedures of the respective college / university in India.

**Guidelines for AYUSH Scholarship Scheme**

- No application will be accepted after last date of application.
- The application will be processed only for the course applied for. No request for transfer of University / change in course will be entertained at any stage once the admission is confirmed.
- The eligibility criteria and other terms and conditions for admission of the respective university will be applicable.
- The candidate has to fill 03 choices of Universities in the application in order of preference.
- The allocation of University will be subject to availability of seat. If no seats are available in the choice of University given by the candidate, the allocation of University will be done by the Ministry of AYUSH in other University as per the availability of the seats.
- Ministry of AYUSH may decide about the selection criteria from time to time.
- The Medium of teaching will be English and/or Hindi
- Equivalence certificate for the foreign candidates is obtained by the ICCR from Association of Indian Universities. There will be no reimbursement of fee paid by the scholars to Association of Indian Universities for obtaining Equivalence certificate.
- Candidate has to confirm / deny the offer of admission within 15 days of receiving the offer after which it will be considered that the candidate is not interested and the seat will be offered to the next candidate in the waiting list.
- There is no provision for Health/Medical insurance for the AYUSH scholars
- Economy class Airfare by shortest/ cheapest route will be provided to the scholars once at the time of admission and once after completion of the course.
- The air tickets for to & fro journey to the scholar will be provided by the concerned Indian Mission / ICCR.
- In case of urgency, the candidate has to inform about the travel plans/ itinerary to ICCR and seek the prior approval to ICCR before booking the air tickets. No reimbursement of cost of air tickets / booking charges of the air tickets will be made to the scholars if the tickets are not booked with prior approval of ICCR.
- Reimbursement of House rent Allowance (HRA), other allowances etc. will be settled in the ongoing financial year (on producing authentic bills/receipts/supporting documents). Request for reimbursement of allowance for past financial year/ years will not be entertained.
- No allowance/fee other than mentioned in the terms and conditions at Annexure – VI will be provided/reimbursed.
- Any matter not covered above will be referred to Ministry of AYUSH, decision of which will be final.

**Eligibility:** 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- c) **Bachelor of Unani Medicine and Surgery (BUMS):** 5 ½ year degree course including one year mandatory clinical training (internship)  
**Eligibility:** 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- d) **Bachelor of Homeopathic Medicine and Surgery (BAMS):** 5 ½ year degree course including one year mandatory clinical training (internship)  
**Eligibility:** 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- e) **B.Sc in Yoga:** 3 year course  
**Eligibility:** 12 years of schooling
- f) **B.A. (Yoga Shastra):** 3 year course  
**Eligibility:** 12 years of schooling

**Post Graduate Courses**

- a) **M.D. Ayurveda:** 3 year course  
**Eligibility:** BAMS degree recognized by Central Council of Indian Medicine (CCIM)
- b) **MD Siddha:** 3 year course  
**Eligibility:** BSMS degree recognized by Central Council of Indian Medicine (CCIM)
- c) **MD Unani:** 3 year course  
**Eligibility:** BUMS degree recognized by Central Council of Indian Medicine (CCIM)
- d) **MD Homeopathy:** 3 year course  
**Eligibility:** BHMS degree recognized by Central Council of Homeopathy (CCH)

**Ph.D. Courses**

- a) **Ph.D in Ayurveda:** 3 year course  
**Eligibility:** MD (Ayurveda) degree recognized by CCIM
- b) **Ph.D in Unani:** 3 year course  
**Eligibility:** MD (Unani) degree recognized by CCIM
