All Afghan Visa holders need to register within 7 days of arrival into India with the proof of residence and four photographs. Details are given below:

(A) Registration can be done at **Foreigners Regional Registration Office (FRRO)** in New Delhi, East Block-VIII, Level-II, Sector – 1, R. K. Puram, New Delhi – 110 066. Contact Telephone Number is (011)-25696075.

(2) راجستريشن همچنان در دفاتر راجستر خارجي ها در بمبي – چيني – کلکته و امرتسر نیز صورت ميگيرد .

(B) Registration can also be done at the office of FRROs in Mumbai, Chennai, Kolkata and Amritsar.

(3) راجستر براي همه فاصله هاي ديگر در دفاتر ساحوي پوليس در شعبه ناضرين پوليس صورت ميگيرد .

(C) For all other destinations, the registration can be done at the office of **Superintendent of Police (SP)** located at the respective district headquarters.
