## **SECTION-1: NOTICE INVITING TENDER (NIT)**

1.1 Embassy of India, invites **Tender for (a) Preparation of wall surfaces with PoP (Plaster of Paris) on Ground Floor, (b) Painting of Wall surfaces and (c) Restoration of Old wood surfaces (including stripping of old paint) and polishing of wooden surfaces in Ambassador Residence, India House, Embassy of India, Kabul** as per the specifications given in the tender documents.

1.2 The tender document can be received from EoI, Kabul from **21/05/ 2021** on wards. No fee for Tender Document will be charged.

1.3 The interested firms/agencies should submit their bids as explained in the tender document.

1.4 Earnest Money Deposit (EMD) of **US\$ 500/-** (US\$ Five Hundred only) in the form of bank Guarantee/Demand Draft in favor of "Embassy of India, Kabul" is required to be submitted along with tender bids.

1.5 The bidders have an option to submit, in lieu of EMD of **US\$ 500/-**, a **signed undertaking** to the effect that if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a Performance Security before the stipulated deadline, they will be suspended for a specified time period from being eligible to submit bids for contracts with the Embassy of India, Kabul. The time period will be decided by Embassy of India, Kabul.

1.6 Bids can be submitted on any working day from **28.05.2021 to 04.06.2021** (from 0930 hrs to 1700 hrs).

1.7 The Embassy of India, Kabul reserves the right to reject any or all the bids, or cancel the tender, without assigning any reason and the decision of the Embassy of India, Kabul shall be final and binding.

1. We have examined and have no reservations to the Bidding Documents, including addenda issued in accordance with Instructions to Bidders.

## Section 4: Scope of Work

The work involving **(a) Preparation of wall surfaces with PoP (Plaster of Paris) (b) Painting of wall surfaces and (c) restoration of old wood surfaces (including stripping of old paint where required) and polishing of wooden surfaces**, is to be undertaken in the GF area, as specified in this section.

### [A] GF Areas to be covered during the execution of the above mentioned works:

1. Main entrance hall, and attached bathrooms. (*Strong Room excluded*)
2. GF Landing area (*Gallery leading to kitchen excluded*).
3. Drawing Room
4. Dining Room
5. Solar Room.

### [B] Preparation of wall surfaces with PoP surfaces.

Successful bidder would be required to prepare all wall and ceiling surfaces in the areas specified in section A with Plaster of Paris (PoP).

Due care to be taken to ensure that area around light fittings, switch boards are properly prepared so that removal of these fixtures during routine maintenance does not lead to the damage of the PoP surfaces.

Due care to be taken to ensure that area along the margins of the floor and roof skirting edges are properly defined including, if necessary, by removal of the skirting and their re-installation.

Due care to be taken to ensure that the areas behind radiators are also to be surfaced with PoP. This will require de-installation and re-installation of all radiators during the works.

In the GF landing area, PoP surface preparation will be undertaken upto the first section of the stairways including the lighted alcove.

In the Drawing Room area (*sunken portion*) fresh PoP cornices to be prepared in the ceiling areas.

Traditional cornices in the Drawing Room, Dining areas to be restored if wooden or cleaned and repainted if made of PoP material.

All old *Bukhari* chimney vents to be closed and filled, as part of the surface preparation jobs in the above mentioned areas.

### [C] Painting of surfaces.

The successful bidder would be required to paint all wall and ceiling surfaces with high quality washable Plastic Emulsion, in a shade of white to be selected by the client.

Ceiling Cornices with traditional pattern shall be painted with high quality gold colored emulsion paint.

Ceiling cornices with strait patterns shall be painted white/gold as selected by the client.

**[D]** *Wood restoration and polishing.*

Cleaning, Restoration (stripping of enamel paint wherever present) and polishing will be undertaken in the areas specified in section [A].

Due care will be taken to strip wooden surfaces of enamel paint including floor skirting, wooden wall panels, conduct basic repair and repolishing of wood while maintaining its old look. It may be noted that the primary objective of the restoration is to retain the old well worn look of the flooring, and not to restore it to a brand new status.

The wooden floor surface to be sprayed with a protective material to facilitate future cleaning (*bidders are required to propose the optimal solution for the same*)

**[E]** *Miscellaneous Guidelines*

Successful bidder is obligated to ensure least disruption to remaining parts of the Residence, including by ensuring cleanliness at all times of work areas, avoiding spread of dust, and ensuring work site is cleaned every day.

If required to remove radiators, light switches, light fixtures etc during PoP, painting or polishing, the successful bidder will restore all these fixtures to their original functional status.

## **SECTION-5: EARNEST MONEY DEPOSIT (EMD)**

5.1 The amount towards EMD is **US\$ 500/-** (US\$ Five Hundred only).

5.2 The tender documents should be accompanied by Earnest Money Deposit (EMD) of appropriate amount, in the form of Bank Guarantee, in favour of "**Embassy of India, Kabul**".

5.3 EMD will **not** be accepted in the form of Cash/Cheque/ or any other form except Bank Guarantee . No interest shall be payable on EMD.

5.4 Bidder can submit an undertaking, as in **Annexure-1** to this tender document, in lieu of EMD.

5.5 Bids submitted without "EMD" or "Undertaking in lieu thereof" will stand rejected.

5.6 The EMD will be returned to the bidder(s) within 30 days from the date of issuance of the Notification of Award of Work on the selected bidder or cancellation of the tender.

5.7 The EMD shall be forfeited:

a. If the bidder withdraws the bid during the period of bid validity specified by the bidder in the bid form.

b. In case of successful bidder, if the bidder

(i) fails to furnish required Performance Bank Guarantee in accordance with the terms of Tender Documents within the time frame specified in the tender document

(ii) fails or refuses to honour his own quoted prices for the services or part thereof.

## **SECTION- 6: MINIMUM ELIGIBILITY CRITERIA**

### **6.1 The following shall be the Minimum Eligibility Criteria for selection of bidders at the technical stage of the bidding process:**

- a. **Legally Valid Entity:** The bidder/bidding firm should necessarily be a legally valid entity either in the form of a Limited Company or a Private Limited Company registered under the relevant Act or a firm having valid Trade License granted by the City Corporation to do business.
- b. **Registration:** The bidder/bidding firm must have registration with the concerned authority in Afghanistan. The company should have the necessary permits and requisite security clearance to carry out work inside the Green Zone in Kabul.
- c. **Experience:** The bidder/bidding firm shall have experience in whitewash/painting/applying PoP or any other civil works.
- d. **Company profile/information regarding key personnel:** The bidder/bidding firm shall also include in its bid, as per pro-forma at Annexure-5 to this tender document, details about the company and its key personnel.
- e. **EMD or "Undertaking in lieu thereof":** The bidder/bidding firm should attach the EMD of appropriate value or Undertaking in lieu thereof, as prescribed in Annexure-I of this tender document.

### **6.2 Documents in support of Minimum Eligibility Criteria:**

- a. As proof of having fully adhered to the minimum eligibility criteria at 6.1 (a) above, attested copies of certificates issued by the respective authority should be attached with the bid.
- b. As proof of having fully adhered to the minimum eligibility criteria at 6.1 (b) above, attested copy of Registration certificate should be attached with the bid.
- c. As proof of having fully adhered to the minimum eligibility criteria at 6.1 (c) above, attested copies of experience certificates for complete/ongoing work issued by Foreign Embassies/High Commissions/Government Ministries/Departments/Public Sector Companies/Reputed Corporate Organizations/ Multinational Companies should be attached with the bid.
- d. As proof of having fully adhered to the minimum eligibility criteria at 6.1 (d) above, copies of supporting documents for company profile/information about key personnel should be attached with Annexure-6 to this tender document.
- e. As proof of having fully adhered to the minimum eligibility criteria at 6.1 (d) above, the PO/DD towards EMD or "Undertaking in lieu thereof" (in original) should be attached with the bid.

## SECTION-7: BIDS

### 7.1 Preparation of Bids:

- a. Two-bid system will be followed for this tender. In this system, bidder must submit his offer as explained below.
- b. **Envelope No. 1: "Technical Bid":**
- (i) Duly filled Technical Bid with proper seal and signature of authorized person on each page of the bid should be submitted.
- (ii) All the necessary documents including those in support of Minimum Eligibility Criteria should be submitted with Technical Bid. These documents should be self-attested.
- (iii) EMD should be submitted with the "Technical Bid". **Bidders can submit an undertaking in lieu of EMD as prescribed in Annexure-1 of this tender document.**
- c. **Envelope No. 2: "Financial Bid":**
- (i) Bidders must quote the price in the format given in **Annexure-2** to this tender document.
- (ii) No other documents except "Price Schedule" may be submitted along with Financial Bid otherwise the bid shall stand rejected.
- (iii) All amounts are to be quoted only in **US\$**. The price quoted shall be considered firm and no price escalation will be permitted. The prices quoted should be inclusive of charges for freight, insurance, packing, after sales service etc.
- d. Both the technical bid and financial bid envelopes should be sealed separately and clearly marked as "Envelope No. 1 - Technical Bid" and "Envelope No. 2 - Financial Bid".
- e. Both the sealed envelopes should be placed in a third larger envelope clearly mentioning "Technical Bid & Financial Bid " **Tender for (a) Preparation of wall surfaces with PoP (Plaster of Paris) on Ground Floor, (b) Painting of Wall surfaces and (c) Restoration of Old wood surfaces (including stripping of old paint) and polishing of wooden surfaces in Ambassador Residence, India House, Embassy of India, Kabul.**
- f. Please write Tender Number viz. No. **KAB/CHY/862/10/2021** on each envelope and seal all the envelopes.

### 7.2 Submission of Bids:

- a. The bid complete in all respect may be submitted to the Head of Chancery, Embassy of India, Wazir Akbar Khan, 14<sup>th</sup> Street, Kabul. *The bids viz. Technical and Financial Bids should be submitted in two sets - one original and one copy.*
- b. The bid should be neatly arranged, plain and intelligible. The language of the bid should be **English** as far as possible.
- c. Each page of the bid should be signed by the authorized official of the company..
- d. Bid should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will summarily be rejected.
- e. Insertions, postscripts, additions and alterations in the bids submitted shall not be recognized, unless confirmed by bidder's signature.

### 7.3 Deadline for Submission of Bids:

- a. Bids must be submitted on or before **04.06.2021 (1700 hrs)** which is the last date for submission of bids.

b. In the event of the specified date for the submission of bids being declared a holiday for the Embassy of India, Kabul, deadline for submission of bids will stand extended to the next working day up to the same time.

c. The Embassy of India, Kabul may extend the deadline for submission of bids by amending the bid document and the same shall be notified on the website of the Embassy of India, Kabul.

d. No bid (s) will be accepted after the deadline for submission of the bids.

#### **7.4 Validity of Bids:**

a. Bids shall remain valid and open for acceptance **for a period of 180 days** from the last date of submission of bids.

b. A bid valid for a shorter period shall stand rejected.

c. The Embassy of India ,Kabul may ask for extension of validity of bids for another period of 60 days, without any modifications and without giving any reasons thereof. Such request and the response shall be made in writing only.

d. In case, the Embassy of India, Kabul calls the bidder for negotiation then this shall not amount to cancellation or withdrawal of original offer which shall be binding on the bidder.

#### **7.5 Bid Opening Procedure:**

a. **Technical Bids (Envelope-A)** will be opened in the Conference Room of the Embassy of India, Wazir Akbar Khan, 14<sup>th</sup> Street, Kabul Afghanistan.

b. Bids will be opened **at 1500 hrs on 06/06/2021** in presence of participating bidders or their representatives and the Tender Evaluation Committee (TEC) constituted by the competent authority of the Embassy of India, Kabul.

c. After evaluation of the Technical Bids, the qualified bidders will be shortlisted.

d. **Financial Bids (Envelope-B)** of shortlisted bidders only shall be opened on a subsequent date which will be intimated to them by email/fax.

f. The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date and the time will remain unchanged.

g. A letter of authorization shall be submitted by the bidders' representatives before opening of the bids.

h. Absence of any bidders or their representatives shall not impair the legality of the opening procedures.

i. The authorized representative of bidders, present at the time of opening of the bids shall be required to sign an attendance sheet as a proof of having attended the financial bid opening.

## **SECTION-8: INSTRUCTIONS TO BIDDERS**

### **8.1 Notification of Award of Work:**

- a. Embassy of India, Kabul shall award the work to the eligible bidder whose bid will be accepted and determined as the lowest evaluated commercial bid.
- b. Award of work will be notified as per pro-forma given in **Annexure-3** to this tender document.

### **8.3 Amendment of Tender Document**

- a. At any time prior to the deadline for submission of bids, The Embassy of India, Kabul may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document.
- b. Any corrigendum/addendum to the above tender document, if required, will be hosted on the website of the **Embassy of India, Kabul** as given above.

### **8.4 Purchaser's Right to amend Scope of Work:**

If, for any unforeseen reasons, the Embassy of India, Kabul is required to change the Scope of Work, this change shall be acceptable to the bidder without any change in the price quoted.

### **8.5 Interpretation of the clauses in the Tender Document**

In case of any ambiguity/dispute in the interpretation of any of the clauses in this Tender Document, Embassy of India's interpretation of the clauses shall be final and binding on all parties.

### **8.7 Performance Security (PS):**

- a. The successful bidder has to deposit Performance Security in the form of a Bank Guarantee drawn in favour of the Embassy of India payable at Kabul. If it is Bank Guarantee, the same should be as per the format given in **Annexure-4** to this tender document.
- b. Performance Security will be of an amount equivalent to **10%** (ten percent) of the total Contract Price.
- c. Performance Security should be submitted within **three (03) days** after the acceptance of the Notification of Award of Work by the successful bidder.
- d. Performance Security shall remain valid for a period of sixty (60) days beyond the date of completion of all the contractual obligations of the bidder (Service Provider).
- e. No interest shall be payable on Performance Security.

### **8.8 Payments:**

a. 90% of Contract Price will be paid on successful completion of work of **preparation of wall surfaces with PoP, painting of walls and polishing of wooden work** as per tender document and to the satisfaction of Embassy of India, Kabul.

c. Balance 10% of Contract Price will be paid after 1 year from the date of completion of work.

d. All payments shall be made in Afghanistan, Kabul by means of bank transfer/cheque.

#### **8.9 Penalty for delayed Services:**

a. The work should be completed within **15 days** from the date of awarding the work. The Embassy of India, Kabul reserves the right to levy penalty @ of 1 % of Contract Price per week of delay beyond the scheduled deliveries/execution of the order successfully, subject to maximum of 5% of the Contract Price.

b. The Embassy of India, Kabul reserves the right to cancel the order in case the delay is more than five (05) weeks.

c. The penalties, if any, shall be recovered from the 10% claim due after installation & commissioning or from the Performance Security.

#### **8.10 Force Majeure:**

The Embassy of India, Kabul may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of nature (like earthquakes, floods, storms etc.), acts of states, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises.
